Please make note of the following clarifications and/or changes pertaining to our request for bids for the project shown above. This addendum contains two (2) items ("REVISION" and "QUESTIONS").

ITEM 1: REVISION

ITEM 2: QUESTIONS

Project Scope

1) Does the bid include cleaning all interior and exterior windows and doors at the eight sites, including the glass inside classrooms, the cafeteria, and offices?

SBSD: Yes

2) Are both interior and exterior sides of the windows expected to be cleaned at each location?

SBSD: See question 1.

3) Are skylights part of the areas we should plan to clean? SBSD: No

Water Access:

4) Will water be available on-site, or are we required to bring our own? SBSD: Yes, water will be available on-site.

- 5) Will we have access to water at each site, both inside and outside? SBSD: See question 4.
- Are any water spigots locked, and if so, will access be provided?

 SBSD: Yes, many sillcocks/spigots are locked. Yes, SBSD staff can support unlocking.

Window Access:

- 7) Will interior keys or staff assistance be available to access locked rooms? SBSD: Yes, Plant Foreman will be able to assist with access to rooms.
- 8) Are we permitted to walk on rooftops or overhangs to access hard-to-reach exterior windows?

SBSD: Yes. Adhere to appropriate safety measures. Construction will be taking place on the roof at Solana Pacific and may not be accessible.

Window Preparation:

- When were the windows last cleaned?
 SBSD: The majority of the windows have been cleaned in the last 12 months.
- Will art and adhesive tape be removed from the windows before cleaning?

 SBSD: Items attached to the glass by SBSD will be taken down, and staff are asked to remove adhesive tape. There may be adhesive tape left present on some windows.

Blinds & Screens:

- Do the blinds only need to be wiped down, or is a deeper cleaning required? SBSD: Correct, blinds need to be wiped down.
- 12) Will we be required to wipe down the blinds and shades, or do they need to be removed, cleaned, and then reinstalled?

SBSD: See question 11.

13) If any window screens are damaged before cleaning, do we report them and set them aside?

SBSD: Yes, set aside and report to the district.

- Should we leave weathered and fragile screens in place? SBSD: See question 13.
- 15) Will the shades and blinds be lowered for cleaning at each site, or will we need to lower and raise them ourselves?

SBSD: The vendor will need to raise or lower the blinds to clean the blinds and the windows as needed.

16) Are drapes included, specifically at Solana Highlands? SBSD: No

Foliage & Obstructions:

17) If plants, trees, or shrubs are blocking access to windows, should we work around them?

SBSD: Yes, those windows will need to be cleaned.

Lift and Access Issues:

18) Is a lift available at any of the sites, or will we need to hire a lift company? This is specifically regarding Solana Pacific at 3901 Towngate Drive.

SBSD: Vendor will need to provide their own lifts.

19) Can bars or gates at certain doorways be temporarily opened or removed to allow lift access?

SBSD: Where appropriate, access can be supported to allow lift access.

- Are lifts allowed inside certain buildings, such as auditoriums or stairwells? SBSD: Yes, protecting the floors from damage as needed.
- Are there any height or weight restrictions inside areas where lifts may be used? SBSD: The Vendor will need to protect the floors from equipment.

Amphitheater Area (Solana Pacific):

22) For the tall exterior windows at the amphitheater, is there roof access to reach those windows, or will they need to be?

SBSD: At Solana Pacific, some of the MPR exterior windows are accessible from the roof, via the roof hatch backstage.

23) Will we have roof access at all locations? SBSD: See question 23.

Structural Surfaces:

24) Can we safely walk on the metal grates or walkways near high windows in some interior spaces?

SBSD: These areas would need to be specifically identified and reviewed.

Bonds and Wages

- 25) Is prevailing wage required?

 SBSD: Yes, prevailing wage is required.
- Could you please provide more details on the bonds required?

 SBSD: A Bid Bond of 10% of the total bid price is required to be turned in with the bid proposal due on May 1, 2025, at 2 pm.

A Payment Bond of 100% of the total bid price will be required of the recommended awarded contractor before the work is to be performed.

A Performance Bond of 100% of the total bid price will be required of the recommended awarded contractor before the work is to be performed.
