#### **ITEM 1: REVISION**

##### **A) Prevailing Wages:**

In Addendum No. 2, question number 25: Is prevailing wage required? SBSB had answered: Yes, prevailing wage is required.

Solana Beach School District has determined that prevailing wage will not be required due to the Janitorial Exception per California Code of Regulations, Title 8, Section 16000.
